

**Great Valley School District  
Affidavit – Exemption from FBI Clearance**

I, \_\_\_\_\_, am applying for an unpaid volunteer position with the Great Valley School District in which I will be responsible for the welfare of children and/or will have direct contact with children.

I understand that the Child Protective Services Law requires all such volunteers to complete three background clearances (Department of Human Services Child Abuse Clearance; Pennsylvania State Police criminal background clearance; and federal FBI criminal background clearance). I understand, too, that the law exempts a prospective volunteer from the federal clearance if he or she (1) has been a Pennsylvania resident for the entire previous ten-year period and (2) he or she swears or affirms in writing that he or she is not disqualified from service by reason of criminal history.

If the following statements are true and apply to you, please sign and date below. If you have any questions about your eligibility to complete this form, please contact the District.

I have requested a child abuse background clearance from the Department of Human Services and a criminal background clearance from the Pennsylvania State Police. I am attaching copies of my clearances here. I understand that I will be required to produce original clearance reports before beginning service.

I swear or affirm that I have been a resident of Pennsylvania during the entire previous ten-year period and have not been arrested for or convicted of any of the offenses below or crimes similar in nature, or the attempt, solicitation, or conspiracy thereof, or a similar offense under the laws or former laws of the United States or one of its territories or possessions, another state, the District of Columbia, the Commonwealth of Puerto Rico, or a foreign nation, or under a former law of this Commonwealth.

I understand that I may be accepted to serve on a provisional basis for a single period not to exceed thirty (30) days at the discretion of the District. I swear or affirm that I am in compliance with the clearance standards under the law of the jurisdiction where I am domiciled. I further understand that, during any provisional period, I may not work alone with children and that I must work in the immediate vicinity of a permanent employee of the school.

I hereby swear or affirm that the information set forth above is true and correct to the best of my knowledge and belief. I understand that, if information is obtained that I am disqualified from service, I will be dismissed immediately. I also understand that I am signing this document subject to penalty under Sections 4903 and 4904 of the Pennsylvania Criminal Code (false swearing and unsworn falsification).
